#### James Woodward

We were sad to hear in October that long-standing member James Woodward had passed away following a long battle with declining health.

James lived in Derbyshire and owned the Nutbrook herd of White Park cattle, which at nearly seventy in number is one of our largest herds. The current herd sire is Broadecton Clayton, a Pass Plus bull who has also been used for semen collection. James also bred four registered breeding bulls under the Nutbrook prefix.

James' daughter Rosemary said that her father had derived great pleasure from his White Park cattle and was very proud of the herd which he had built up. So, it is good to know that James' two daughters will be taking over the management and development of the Nutbrook herd.

### Membership subscriptions for 2024

During the year our Council members reviewed our fees and came to the difficult decision that it was time to increase our membership subscription. This is the first increase for eleven years.

In line with all businesses, the Society is facing increasing running costs. Our membership subscriptions are one of only two sources of income for us, the other being cattle processing fees. Council members decided not to increase our registration or purchase transfer fees, but the

Bull Inspection fee will be increased to £125 to cover the additional DNA test that we are now undertaking on dams of bulls.

# The membership subscription for 2024 will be £50 and is due on 1 January.

If you pay your subscription by standing order, we would be grateful if you could amend your payment accordingly. We also accept cheques if this is your preferred method of payment.

Invoices will be sent to all members in December to remind you of the new membership rate.

Farmers' Guardian highlights our breed during a momentous year for our society

On 8 December 2023 the White Park breed was highlighted in an article in the Farmers' Guardian, which visited the Blatherwycke Estate

in Northamptonshire. The estate is home to two herds of White Park cattle; the Blatherwycke herd and more recently, the Dynevor herd owed by Lawrence Alderson. Upon his retirement from active farming, Lawrence Alderson passed over the guardianship of his herd to the estate.

The article comes at the end of a momentous year for the society:

- Lawrence Alderson resigned as President following thirty-five years in post
- Alistair Black resigned as Chair following eighteen years in post
- Henry Rusch became our new Chair
- The society celebrated its 40th anniversary

And 2024 will be the 50th anniversary since the re-establishment of registrations and the production of our Herd Book, which was organised by Lawrence Alderson. We hope to organise further publicity about our breed and society anniversaries next year.



### Could you bring on bull calves for possible inspection?

One of our members has raised a query with us, to say that they have three promising bull calves who they are unable to keep beyond nine months old. We are

sure that this is not the only member who does not have the time and land available to bring bull calves on for inspection at two years old.

This issue raises the question - how do we incubate promising bull calves and ensure that they are well handled on a daily basis to become wellmannered breeding bulls?

### **Compensation for TB reactors**

Unfortunately, many of our members are living in high risk bTB areas and losing cattle to the disease is a constant threat. But bTB can occur in any area of the country.

Defra pay compensation for bTB reactors, depending on the sex and age of the cattle. But there is a difference between the compensation paid for pedigree cattle and non-pedigree cattle. The difference can be up to £1137 per head (for a heifer over twenty months).

\*\* It is therefore important that members register their female White Park cattle with us in order to receive a pedigree certificate \*\*

Remember - if you register your calves within three months of their birth, the cost of registration is £25 per calf.

### List of abattoirs which will take horned cattle

Finding an abattoir which will take horned cattle has started to become an issue for some of our members in certain areas of the country. Many small, family firms are closing down, and others are placing restrictions on the type of cattle which they are able to deal with.

Amy Quirk, a student studying agriculture at the the University of Kent, has recognised that breeders of horned cattle are having difficulties sourcing abattoirs and concentrated on the issue for her dissertation. She contacted all registered abattoirs in the UK to ask if they would take cattle with horns plus if they had restrictions on killing cattle over thirty months of old. The final list has been shared with cattle societies which support breeds with horns. If you would like to receive a copy of the list of abattoirs, please contact Jane at the office.

## Animal health and welfare review now open to more farmers

Defra has announced that their annual health and welfare review of livestock is now open to non-BPS registered farmers, meaning more livestock keepers in England can now apply. Through the Review, farmers who keep cattle, sheep and pigs can get funding to pay for a vet to visit their farm and carry out a yearly review. You need to own a minimum of eleven cattle and have a single business identifier linked to a county parish holding number to apply for the grant. You will be paid £522 for the review.
