Update on the AGM

Volume 16 of the White Park Cattle Society Herd Book

This year is a special anniversary for White Park registrations - 2024 is the 50th continuous year of registrations, which were re-established in 1974 following a hiatus of 28 years.

2024 will also see the production of Volume 16 of the WPCS Herd Book. This book is produced every 4 years and lists all female and male registrations since the previous edition, plus transfers of bulls and females, a list of prefixes and a list of members.

Previously, we have always posted out a copy of the herd book to every member. However, mindful that many members prefer electronic copies of documents and also keen to keep our costs low, this year we have decided to ask members whether they want to receive a hard copy of the book. Copies will be available at the AGM and can be collected there, and we will post out copies to members who are unable to attend the AGM. White Park bull sculpture

In late 2023 we were contacted by sculptor Edward Waites, who is planning to produce a White Park bull to add to his collection of stunning animals. Edward asked if he could visit a White Park bull in the flesh, so that he could take some photographs. We therefore arranged for him to visit Tim Harris, host of our 2022 AGM and producer of 42 registered White Park bulls. Alistair Black, our former Chair and a long-time bull inspector, accompanied Edward on his visit to talk him through the finer points of a White Park.

Edward plans to produce the final sculpture as a limited edition which will be for sale. So, watch this space and we will let you know as soon as the finished sculpture is available. In the meantime, you can take a look at Edward's work on his website.



Hair samples for bull inspections - by Lawrence Alderson CBE

The procedure for the inspection and registration of a White Park bull includes not only an evaluation of the type and merit of the bull but also DNA verification of his parentage to prove he is a purebred animal.

Parentage verification requires DNA testing at 50,000 SNP markers of an animal, and of its sire and dam, to show the recorded pedigree of the bull is correct. This is an integral and essential part of the registration process. A hair sample is taken from a young bull at his inspection to be tested. A SNP test result is already available for the sire of some young bulls, but if such a result is not available the

It is likely that a SNP test result will not be available for the dam of the young bull and therefore she must provide a sample for testing.

A possible loophole in the system is that a young bull may be parentage verified but his dam may not be purebred. Therefore, it is necessary also to test his dam to show she is purebred.

To be eligible for registration, both the bull's parents must be pure-bred. A hair sample is therefore required from the dam either before or at the inspection. The best way of ensuring that a hair sample is available from the dam is to take this at an early stage, soon after the bull is born. The sample can be sent to Jane at our office for safe keeping. We also encourage members to send a sample from the bull at the same time.

Vet Attestation Rules

Unless you are part of an assurance scheme, farmers now need a signed declaration from their vet to comply with export requirements. Even when meat from animals is not intended for export to the EU, there is a high likelihood that some of the animal products or by-products derived from them may be included in exports to the EU. Therefore, it is recommended that all farm businesses ensure a veterinary visit has taken place at their farm.

Obtaining a signed veterinary attestation must be done at **least once over a 12-month period** and can be combined with any other routine veterinary visit, such as TB testing. The vet will generate a receipt of the visit and a VAN (Vet Attestation Number).

You don't have to send paper copies of the vet attestation form with each animal or batch of animals which go to market or to a slaughterhouse, you just need to include the VAN on movement records. However, you should retain the copy of the vet attestation form and make it available on request for random verification checks.

List of abattoirs which will take horned cattle

Since our article about the recent research into which abattoirs will take horned cattle, being undertaken by student Amy Quirk, three more of the abattoirs on her original list have closed down. One of these is Long Compton abattoir in south Warwickshire. Such is the depth of feeling in the area that a group of farmers has come together to raise enough funding to buy the abattoir site and re-open it under shared ownership.

Amy is continuing her research and has been invited to sit on various panels discussing the issue of small abattoirs. She is going to keep us updated on developments.
